EMMA TALKS TRANSATLANTIC TRADE AT BRITISH-AMERICAN **BUSINESS COUNCIL**

Emma took part in the British **American Business Council's** "Annual Interview" and shared her insights on the future of the **UK-US** relationship.

In June 2018, Fmma participated in a panel with US Ambassador to the UK, Woody Johnson, to discuss how the UK and US can continue to find common ground and work together to strengthen the transatlantic relationship.

Emma discussed the main areas of opportunity for a UK-US free trade agreement, how the UK can work with the US to reform the World Trade Organisation, and the ways forward for addressing US tariffs on steel and aluminium

Emma said. "With the UK's withdrawal from the EU fast

approaching, I am continuing to champion the UK's trading interests in the European Parliament and abroad. Brexit



is a fantastic opportunity to forge free trade agreements with natural allies who share our values, culture and principles, and it is in this spirit that I believe in a strong transatlantic relationship with many opportunities for the UK and United States

To deliver a successful Brexit, both have attended meetings and events across Europe to secure support for an ambitious free trade deal, protect the integrity of the United Kingdom and protect the rights of both UK citizens in Europe and Europeans in the UK. In particular, Emma, in her capacity as Chair of the Commonwealth Forum, has been working to boost Commonwealth cooperation after the Commonwealth Summit in London this April, Rupert. meanwhile, has been working to reinvigorate cultural and economic ties between northern European and Scandinavian states through Proiekt Hansa

Both Emma and Rupert have steered legislation to ensure it benefits UK businesses, consumers and residents of the East Midlands, Emma has pioneered a report on Blockchain; ensuring that cutting-edge technology drives innovation and streamlines business costs. She has also helped steer

the EU-Japan Free Trade Agreement through the European Parliament; the largest trade agreement ever negotiated. She did this while championing creative industries through the Copyright Directive and continuing to drive to kick corruption out of

Rupert, in his role as Spokesman on the Energy Committee, has helped to decommission old soviet nuclear power stations in Lithuania. As the Shadow Rapporteur on the Environment Committee. Rupert has been involved with the public procurement of low emissions heavy goods vehicles, this will mean not only a better environment and a reduction in emissions but should also save businesses money on

In a busy year for the East Midlands MEPs. Emma and Rupert have fought hard for the East Midlands; ensuring the region's voice is heard loud and clear across the continent.

PROTECTING LOCAL **FOOD & DRINK**

In March, Rupert launched his 'East Midlands Food and Drink Heroes' campaign to recognise the wonderful food and drink produced in the region

Not only does this campaigr celebrate the highquality food and drink produced across the East



Midlands, through the Heroes certificates, it also aims to lobby the Government to continue the regional protection schemes which have ensured that specially certified produce are protected from substandard imitations using the same name.

These protections are in place to ensure that Melton Mowbray Pork Pies cannot be made elsewhere or to a lower standard and still be labelled as being from Melton Mowbray. These protections not only help to preserve the sometimes historical nature of the food and drink but local jobs also.

Rupert has taken his campaign to the Government and has written to the Secretary of State, Rt. Hon Michael Gove MP, as well as setting up a petition on the Government's website to ensure that the message gets across clearly

Rupert said; 'It is vitally important to local jobs that we keep the protections in place following Brexit. I want to see these protections expanded, where reasonably possible, and included within all trade agreements around the world. I believe that we should be proud of our produce and sell it as far and wide as possible - I hope to see Stilton cheese in Korea or Pork Pies in Australia!

EAST MIDLANDS BUSINESS GIVE THUMBS UP TO PROJEKT HANSA



In January 2018, Rupert launched Projekt Hansa, a group which seeks to look for opportunities for trade and the sharing cultural exports across Northern Europe, Nearly a year on and we have been striving to build a network of like-minded stakeholders across Northern Europe, underpinned by trust, with the ambition to pursue shared economic interests Here are some notable highlights from 2018:

We hosted business hubs and conferences in the East Midlands throughout the year. Nottingham and Boston were iust two of the locations where local businesses came together

to engage with our Northern European neighbours and discuss the future of exports/ imports, the labour market. tourism, and the cultural nuances in foreign markets.

Focussing on Iceland, we held an exhibition on its natural resources in March, followed by an interview with Iceland's ambassador to the EU Mrs. Bergdís Ellertsdóttir, and the publication of The view from Iceland - Being Free and Being Free to Trade by historian and political journalist Hjörtur J. Guðmundsson.

A key issue for the group this year has been fishing, a crucial aspect of Northern European trade and Brexit. In June, we hosted a debate on the future of fishing trade with Dutch MEP Peter van Dalen and thereafter published *The Future of Fishing*.

Both contributions stressed the importance of cooperation and interconnectivity of the fishing

EMMA HOLDS FIFA TO ACCOUNT

Emma hosted a conference in the European Parliament with Damian Collins MP, bringing together FIFA, UEFA, the UN. Europol and other key organisations to discuss how to tackle corruption in football.

In April, Emma chaired a panel in the European Parliament of experts in football and law enforcement to discuss how to kick match fixing out of football. This panel built on her work as an MEP since 2009, to make sport, and sport governance, more transparent and effective

The panel included representatives from different organisations, such as Vincent Ven from Fifa; Nick Raudenski from UEFA; Ronan O'Laoire from the UNODC; Sergio D'Orsi from Europol: and Ramon Vega, ex-Swiss international footballer and sports advocate.

The panellists discussed the importance of sharing information between international governing bodies

in the sport, in order to coordinate their approaches

Emma said, "I was delighted to bring representatives of football governance bodies together with international law enforcement



agencies to really highlight the problem of match fixing in football, especially in a World Cup year.

She added, "My conference demonstrated the need for open and frank discussions about how we tackle corruption in football, and the importance of upholding virtues in sport such as fair play, responsibility and eniovment for fans.

Emma & Rapert **BOOSTING COMMONWEALTH COOPERATION**

Over the course of 2018, Emma has championed the Commonwealth and promoted closer cooperation between its members, the UK and the EU.

Emma said: "Brexit gives the UK the opportunity to define Global Britain in the eves of 2.4 billion Commonwealth Citizens, Global Britain must be a champion of free trade for mutual prosperity. Global Britain must take the international lead by lifting the barriers that

too often hamper development, equality and education.

In 2018 Emma held a number of events. designed to promote closer-cooperation between the UK and the Commonwealth. In

January, she held a roundtable on EU-Commonwealth cooperation post Brexit, a Reception to celebrate Commonwealth Day in March and two further roundtable events

> to discuss the Future of Economic Partnership Agreements and Zimbabwe's pplication to join the Commonwealth, She also attended a Trade Delegation to the Commonwealth Games and Commonwealth Summit this April.

She added that: "2018 has been a crucial year for the United Kingdom's future relationships across the

world. I have spoken to people from across the Commonwealth this year and it is imperative the United Kingdom makes use of Brexit as an opportunity to champion free trade, drive change and equality to make sure no one is left behind.


